Α. Shoshana Wechsleir, Sunflower Alliance

Banning Oil/Gas Drilling - Shoshana worked with students from Heritage High School to put together a proclamation to ban oil and gas. This was delivered to Antioch City Council and was passed. They presented this to Brentwood who passed a moratorium on oil and gas while they look at legal ramifications. It was also presented in Oakley with no action taken. Sunflower Alliance is now working with the County to stop oil and gas drilling on county land. Shoshana is a climate and environmental justice activist who lives in West County. She is supervisor John Gioia's representative for District 1 on the Sustainability Commission for the County. She has been primarily involved in fossil fuel issues in Contra Costa County for about 11 to 12 years.

Notes from Shoshana Wechsleir's presentation

State-level oil and gas drilling:

Over 2 million Californians live within a half-mile of an oil and gas well. Five million live within a mile of an oil and gas well. That's 7 million Californians severely impacted by oil and gas drilling, subject to asthma and other lung disease, heart disease, reproductive impacts, cancer, and so on.

This makes for a very big public health crisis.

Two years ago, a Public Health Scientific Advisory Panel on the health impacts of fossil fuel extraction called together by Governor Newsom concluded that a **minimum** health and safety zone—or setback—should be established at 3200' feet (approx. ½ mile) from wells. Importantly, it also advised that the most health-protective measure was to stop drilling altogether.

That 3200' health protection zone (the minimum setback distance from oil and gas infrastructure) was established last year by the passage of Senate Bill 1137, and only for new drilling and reworked active wells. But this unfortunately was stayed by the fossil fuel industry, which spent 20 million dollars this last year on a deceptive referendum campaign. That law was supposed to have gone into effect in January. Now it's on hold until the November 2024 election—and only if we can fight back the repeal effort.

So where does that leave the 7 million Californians?

Since January, a total of 649 neighborhood drilling permits to upgrade, redrill, and retrofit oil wells have been released by our state oil and gas regulator, CalGEM—most of them this month—and 398 of them, or 60%, are in the 3200' health buffer zone established by SB1173.

A big oil and gas field was discovered in East Contra Costa in 1962 and a drilling heyday followed. Chevron and Exon drilled all over the Old Brentwood Oil and Gas Field until they decided it wasn't worth it any longer. The legacy of that drilling is 273 plugged and abandoned zombie wells all over East County, with a good number of them under Brentwood.

All of these can be reactivated at any time, given current city, county and state regulations.

In 2019, it slipped past all of us that the County had allowed a drill pad to be constructed on Deer Valley Road, alarmingly close to a medical high school, Kaiser Antioch, and pending senior housing.

A year later came the Powerdrive proposal to do exploratory drilling within 900 feet of a Brentwood neighborhood.

That launched a campaign to end drilling in the county.

Success stories thus far:

A petition to ban new drilling and phase out existing drilling now has **3,823 signatures** mostly from Contra Costa residents. Let's get it up to at least 4,000!

Antioch has banned oil and gas drilling within its city limits, and has passed a resolution addressed to the County to ban and phase out.

Brentwood passed a moratorium on drilling—which is expiring on April 11. ***It is likely that the City Council will have this on their March 28th agenda.***

qThe Democratic Party of Contra Costa passed a resolution—yes!—urging the County to end permitting of new oil and gas infrastructure, phase out existing drilling in Contra Costa, and transition any impacted fossil fuel workers to good careers in climate-friendly industries.

So did the Diablo Water Board!

Over 50 County-based environmental and social justice organizations signed an anti-drilling letter; 130 Contra Costa medical health practitioners signed a similar letter sponsored by Climate Health Now.

Three cities—Antioch, Richmond and Pinole—have passed solidarity resolutions w/ East County cities, urging the County to ban drilling. More city council resolutions are underway.

Remember, this is all about convincing the County to change the land use policy in its General Plan. (The current General Plan "encourages oil and gas drilling to promote the feasibility of agricultural land.") The final draft is coming out very soon. Last year the County said it would follow state policy on setbacks (now in suspense), but would not prohibit drilling outright. That means it would continue to rubberstamp drilling proposals for another 20 years.

As for the state, last year it rubberstamped an injection well across from the Deer Valley Rd site. Said it was CEQA exempt—no public environmental review needed! For more information on this—Sunflower Alliance sued CalGEM, the state oil and gas regulator over this—please see https://www.sunflower-alliance.org/why-were-suing-calgem/. We won the ruling but expect the oilies to appeal.

We need to do everything we can to influence policy on both the state and local level, such as in Brentwood.

Please email the Mayor and City Council by March 27th and tell them you want to see oil and gas drilling prohibited in the City of Brentwood—to protect the health of the community and to enact sane, climate-protective policy.

- D. Doug McClelland attempted to break through some of the confusion and misdirection regarding issues of Trump and Biden by passing out a multi-state analysis of the election results in each of the five swing states. It's a short easy read and is attached.

Additionally, he summarized a 2020 report by SIGAR--a Bush-created agency responsible for issuing quarterly analysis of the Afghan war. You can go to the site

(https://www.sigar.mil/about/index.aspx?SSR=1) or just take a moment to read Doug's summary:

Under President Biden's predecessor, **Donald Trump**, the United States made a deal with the Islamist Taliban to withdraw all American forces. "**The biggest factor that led to the collapse** of the Afghan military in August last year was the U.S. decision to withdraw forces and contractors from Afghanistan through an agreement with the Taliban **signed by the Trump administration."**

After the signing of the deal, "the U.S. military support to Afghan forces came down, which also included a *drop in air strikes in 2020* after a record high level in the previous year", the report added. "Limiting airstrikes [in 2020] after the signing of the U.S.-Taliban agreement... left the ANDSF (Afghani National Defense Special Forces) without a key advantage in keeping the Taliban at bay," John Sopko, the Special Inspector General for Afghanistan Reconstruction, said.

The botched withdrawal from Afghanistan was actually set up and pre-ordained by Trump according to SIGAR, an agency created by then-President Bush and appointed by Congress which has been tasked since 2008 on making quarterly reports on Afghanistan.

VII DPCCC District 3 Update – Carolina Villaseca, DPCCC District 3 Director (3 minutes)

- A. Antioch Dr. Jag introduced an Equity in Education Audit that will help the school evaluate the culture, curriculum and instruction of each school. And it helps improve the performance through data and modeling of similar successful schools. Councilmember Wilson put forth an initiative to stop an additional beverage store in a part of Antioch saturated with liquor stores. Dominique King collected over 300 signatures in this effort. After many years of work by Harry Thurston and others, Antioch is finally moving forward with the Citizens' Police Oversight Committee. The 20 applications are being reviewed and the committee should start their work in the next month or so.
- B. Oakley The council asked for feedback in a sports complex on 55 acres. Look for additional meetings coming up.
- C. Discovery Bay Opened a new boat repair shop. This is great as we have a lot of avid boaters in East Contra Costa. All local dignitaries were present.
- D. Brentwood BUSD is going thru redistricting. New school TK-5 eventually 8th. Growing 25% year over year. The overwhelming majority of houses built in Contra Costa are in D3. Working on a Youth Sports Complex at Fairview and Sand Creek. The next meeting will include a 3rd rendition of all the feedback from the first two workshops. Please look on our Facebook for the next meeting.
- E. Bethel Island The sanitary district wants to develop the island. Very preliminary. They're getting 47 new homes that will increase the population by 42% in one fell swoop. They have one way to egress in case of an emergency, so this is a huge increase in population.

F. Hijas del Campo - Marivel Mendoza Matheu founder, has resigned from her day job to be the Director full time. This organization has done amazing things in only 3 years, and they are looking to expand their reach and help more campesinos.
