VIII Voter Outreach – Linda Smith (5 minutes)

- A. Update on Farmers' Market We have all needed volunteers for the remainder of July. We will contact the membership by email regarding volunteer needs for August.
- B. Postcard/Letter Writing
 - 1. We've written **300 postcards** for the Center for Common Ground, for the Florida Primary, to get people ready for November Mailing August 2nd
 - 2. We've written or committed to writing nearly **4,000 letters** to Swing States so far and are concentrating on places Swing Left has identified as critical: Arizona, Florida, Georgia, Michigan, Nevada, North Carolina, Ohio, Pennsylvania, Texas, and Wisconsin. The goal is to increase participation of historically underrepresented communities and Democratic leaning voters in midterm elections. The letters will all be stored and mailed on October 29, 2022.
 - 3. We've written **200 postcards** for Swing States (Nevada, Georgia, Arizona, Pennsylvania, or Wisconsin) Mailing October 19th
 - 4. Linda is holding letter and postcard writing parties at her home <u>every other</u> <u>Wednesday from 10:00 am to noon</u>. The next postcard party will be on August 3rd.

IX Swing Left Director – Doug McClelland (5 minutes)

- A. Swing Left update and introduction of Tom Dowling, Swing Left representative for Pennsylvania, who will talk about critical races in PA.
- B. Please consider doing a bit more during these critical final months before the November election. We need every current member (and as many new members as possible) to be fully engaged in the effort to preserve our democracy!
- C. We are helping Josh Harder campaign in Discovery Bay and Byron and would welcome your help!
- D. Please speak with Doug if you can participate in any of the following election-related trips we are planning:
 - 1. **Reno**: Register University of Reno students to vote (and then spend the evening having Reno-style fun).
 - 2. Las Vegas (late October): Canvas in Las Vegas to get out the vote (then have another evening of fun this time, Las Vegas style).
 - 3. **Tucson** (late October/early November): Join the "Souls to the Polls" effort to get out the vote.
 - 4. **District 8 in Scranton, PA** (late October): This canvassing trip offers the added advantage of seeing the beautiful fall colors there.

X Issues Committee – Bill Nusbaum (5 minutes)

- A. Meetings first Saturday of the month at 11:30 am. Next Meeting Sat. August 6, at 11:30 am via Zoom.
- B. The Fact Sheet on Gun Control is posted on the website, and the committee is continuing its work on that issue, which has attracted so much additional concern and activism because of the massacres in Buffalo, Uvalde and Highland Park.

- C. **Good news from Sacramento**: The State legislature has passed, and Governor Newsom has signed the following important new gun control laws:
 - 1. **AB 1594**, establishing firearm industry accountability;
 - 2. **AB 2571**, prohibiting the gun industry from marketing firearm-related products to minors;
 - 3. **AB 1621**, further regulating ghost guns;
 - 4. **AB 2156**, cracking down on the manufacture of firearms (including by 3D printing) by unlicensed persons; and
 - 5. **SB 1327**, allowing private individuals to sue people who illegally make or sell assault weapons or ghost gun parts, or who sell guns to those under 21.
- D. In addition, the California legislature is working to pass SB 918, which would improve the State's concealed carry law in response to the US Supreme Court's recent opinion in *NYSRPA v. Bruen*, in which the Court ruled that New York State's concealed carry law violated the Second Amendment.
- E. Although proposed California AB 1223 (which would have imposed excise taxes on the purchase of guns, gun parts and ammunition) was defeated earlier this year by gun rights advocates, it has been reintroduced as AB 1227 and is currently pending in the Senate Appropriations Committee.
- F. Update on other issues the Committee is working on, including enhanced teaching of civics in our public schools. Can you help? We'd love to have you join us!
