XI DPCCC District 3 Update – Carolina Villaseca, DPCCC District 3 Director (3 minutes)

- A. SB345 Dr. Sara Levin, officer of Contra Costa County Board of Health came to our Marsh Creek Democratic club general meeting and had an ask. She is trying to get SB345 authored by Senator Nancy Skinner to the floor of the assembly for a vote to ensure that California will strengthen its standing as a safe haven and national beacon for protecting every individual's right to an abortion, contraception and gender-affirming care. This bill will provide legal protections for California health care practitioners that provide or dispense medication or other services for abortion, contraception, or gender-affirming care, regardless of their patient's geographic location. It has been approved by the Senate. Please call your Assembly people.
