## VI. Guest Speaker

President Villaseca introduced today's speaker Michelle Sinnot Petersen, Leader of the local "Mom's Demand Action" chapter. Moms Demand Action (MDA) is a grassroots movement of Americans fighting for public safety measures that can protect people from gun violence. Ms. Petersen also serves as a delegate for the California Democratic Party and following an unsuccessful run for the School Board in Danville, helped start the Lift up Our Schools coalition within Alameda and Contra Costa Counties.

Ms. Petersen noted that with ten million supporters, MDA has changed the tide of gun violence prevention in America, yet still every day over 100 people in America are victims of gun violence. African Americans are ten times more likely to be victims of gun violence, and firearms are the leading cause of death in the United States. Two thirds of all suicides are from guns. Indeed, there are more guns in America than there are people.

MDA has been working on numerous remedies and proposals, for example to increase the waiting period throughout the U.S. to 72 hours. While California has a waiting period, Nevada does not, and a recent murder was committed by a resident who simply traveled to Nevada to purchase a weapon before using it on another citizen.

Another effort in Jan Jose requires gun owners to purchase insurance, the proceeds of which go to victims of gun violence.

# IX. Social Justice – Ray Cole, Chair (report below, not in attendance)

- a) Met with the librarian for the Brentwood Library, Andrea Freyler to understand how books are selected for the library; the process for handling requests for banning or restricting books; and ask if there have been requests for banning books and, if so, how were they handled.
- b) Andrea was very open and helpful. Books are selected on the county level and there is a very detailed written policy that governs the process. In general, books are assigned by reader age groupings and a large variety of books are added to the inventory. There have been no requests for banning books at this location, so it is currently not an issue. Good news. I came away with a much greater appreciation of our library.
- c) I am continuing to read the top 10 banned books of 2023 and have three more to go. The intent is to write short 'book reports' for these and then change focus to another area. My current sense is that homelessness, Prop 1, and criminal justice (probably property crimes) are the areas that deserve attention. Am open to suggestions and, as always, volunteers to take on these or other issues.
