Bill Nusbaum, chair of the MCDC Issues Committee, will present an analysis of the seven Propositions on the California ballot. Don Smith initially completed a comprehensive study of the propositions. Then Don met with the Issues Committee to review that analysis and prepare the MCDC voting recommendations. Everyone in attendance at our meeting today will receive a copy. Our recommendations will also be emailed to everyone on the MCDC mailing list following the meeting. With so much money being spent to sway voters on some of the propositions, we believe it is essential that you cast your votes based on a clear understanding of the issues, intended outcomes of the propositions should they be approved, and who is sponsoring and/or funding them.

Linda's letter writing parties were a fun way to reach our letter writing goals while also making some new friends.

Our goal has been to increase participation of historically underrepresented communities and Democratic leaning voters in midterm elections. The letters have been stored and will all be mailed on October 29, 2022. Remaining postcards will be mailed on October 18<sup>th</sup>.

B. At the Executive Board meeting of October 2, the Board approved a \$200 expenditure for the purchase of plaques honoring Sue Higgins and Jerry McNerney. In addition, the Board approved the payment of the remaining balance due for rental of this meeting room for 2022, which is \$945.
