1.1 - Why are you running for this office? Give no more than your three top reasons.

The office of the County Clerk-Recorder requires a leader who operates with the highest integrity, ethics, and attention to detail. I am committed to providing transparency about the elections process, to battling misinformation to maintain confidence in our elections, and to ensuring equitable access to voting. My strengths as a leader and manager, combined with my interest in and passion for increasing civic participation and voter access inspired me to run in 2022.

1.2 - What is your understanding of the job?

- The County Clerk-Recorder is responsible for leading the Clerk-Recorder-Elections Department for Contra Costa County, including its 82 full-time employees, across separate divisions. This role supervises the senior leaders in the department, including the Deputy Clerk-Recorder, Tommy Gong. If elected to this role, I would be responsible for the results of the Department's work and maintaining the high degree of customer service for which the office is known.
- The Elections Division administers all aspects of elections in Contra Costa County, including candidate services and voter registration, as well as all aspects of conducting elections including ballot design, maintaining the voter file, and mailing ballots to voters. Establishing and managing polling places, including the recruitment and training of poll workers is also a crucial part of the Elections Department. Working across jurisdictions in the county to ensure equitable and accessible early voting sites, as well as Election Day polling sites is also part of the work of the office. I would want to work with the Elections Department to expand their outreach efforts and to increase the scale and scope of voter registration efforts to improve access to voting for underserved parts of the county.
- This office also touches on many important life events birth, marriage, property transactions, trusts and death. The Department is current recruiting a top Recorder position for the office because of the retirement of a longtime leader in the office. Attention to detail and expansion of technology to record documents,

while keeping personal data secure, will be a priority, if elected.

• If elected, I would work closely with the County Administrator's office to ensure successful funding of the Department's budget, as well as effective union negotiations. Collective bargaining with all unions is handled by the County Administrator's office. County department heads meet regularly through the CAO's office. As needed, I would work with the elected members of the board of supervisors who have ultimate decision-making authority for setting department budgets. My skills as an advocate and with navigating bureaucracy will be helpful in these aspects of the office's duties and responsibilities.

1.3 - What personal and professional qualifications do you believe make you the best candidate?

My professional experiences as a lawyer and non-partisan policy advocate set me apart in this race. I have a long track record of improving every organization with which I am affiliated. My strengths as a leader and manager, as well as my work as an organizational development consultant, make me confident that I am the most experienced and that I will be the most effective in this role. I am proud of my record as an ethical and inspirational leader in both my professional and personal life. It's been gratifying to have been re-elected to the AUHSD Governing Board during these difficult years of the pandemic. I am also proud to have the endorsement of all of my AUHSD Governing Board colleagues. I have the broadest and most diverse coalition of supporters across the county supporting my campaign.

I attended law school in the wake of the Supreme Court's *Bush v. Gore* decision. Throughout law school I focused on learning about the Help America Vote Act (HAVA) which was enacted in the spring of 2002, just months before I started law school. I got involved with the non-partisan Election Protection Coalition. Throughout law school I was a judicial extern, an intern with Environmental Defense and was involved in the Community Economic Development Clinic. After graduating, I worked as an employment litigator at the firm Sidley Austin LLP. Through a program at my firm, I

spent four months working at a non-profit representing 23 low-income women who had been impacted by personal violence. I also represented a Nepalese asylum seeker. All of these experiences prepare me for leading outreach efforts with diverse communities.

When we moved back to Contra Costa County in 2010, I worked for a statewide non-partisan governance reform organization before briefly working as Chief of Staff to Supervisor Karen Mitchoff. For the last 8 years I have been in my current role as President & CEO of the East Bay Leadership Council and Executive Director of the Contra Costa Economic Partnership (EBLC's sister organization) through which I have gained significant experiences working with the board of supervisors and the County Administrator which will be very beneficial, if elected.

1.4 - What are your top issues? How do you plan on achieving them?

My top three priorities:

- 1. Access: Combat election misinformation, educate voters on how to cast a ballot and provide equitable and convenient access to voting.
- 2. Integrity: Maintain a paper trail of every ballot cast, verify voter signatures, and ensure accuracy and security of documents and personal information.
- Service: Maintain service focused on customer service and ensure continuity of service in the event of a natural disaster through coordinated preparedness exercises.

I am the only candidate who was interviewed as a finalist for the appointment of Clerk-Recorder in February 2020. Part of my preparation in that process was taking time off of work to attend the 3-day annual CACEO's New Law's conference in Sacramento in December 2019 to prepare for the interview and for the eventual campaign.

I have extensive and relevant work experience in Contra Costa and am proud that my strong management experience was highlighted when receiving the endorsement of the East Bay Times. I am also a former lawyer. While I am seeking and have received endorsements, I am not offering any (with the exceptions of local school board races as an elected school board member) because that is not something that is appropriate in my current job nor would be it be appropriate as the elected Clerk-Recorder.

I am a current office holder who has won election twice before. I am supported by more than 70 current and former local elected officials from across all regions of the County including Rep. Mark DeSaulnier, Assemblymembers Rebecca Bauer-Kahan, Tim Grayson and Buffy Wicks, as well as DA Diana Becton. I have raised the resources to run a competitive county-wide campaign. My tenure in elected office and in my professional life is without drama or personal controversy – I get along well with my colleagues and the people I work with. Finally, I have adhered to all election laws and rules.

1.6 - This is a 3-Part Question: Why are you seeking our endorsement? How will you use our endorsement? How will you support other endorsed candidates and issues?

I am seeking your endorsement because I closely associate myself with the expansive and progressive policies of the Democratic Party as it relates to election administration and earning your endorsement will help communicate those shared priorities with Democratic voters.

My job at the East Bay Leadership Council requires me to refrain from making political endorsements, but I would also not be comfortable offering endorsements because the Clerk-Recorder must be trusted by all voters. However, as an elected school board member, I will work tirelessly to ensure that the local school boards across the county will not be overrun with conservative, conspiracy theorists and will gladly lend my endorsement and work hard to get Democrats elected.

2.4 - If elected, what would you do to advance more equity, diversity, and inclusion?

Promoting more diversity, equity, and inclusion is a priority in my work as an elected member of the AUHSD and at the East Bay Leadership Council. Continuing this work as the Contra Costa Clerk-Recorder-Registrar would be a natural extension of my current work. I would develop a comprehensive framework to guide all aspects of the

Department's internal procedures and policies (e.g. recruitment, hiring, and promotion) as well as our external facing work with the public. This should include expanding existing partnerships with diverse and inclusive community-based organizations on voter access efforts. I would develop performance indicators, in conjunction with the community stakeholders, that would be reported publicly to ensure accountability for these efforts.

Kristin Connelly Biography

Kristin Connelly's commitment to fair, impartial, and secure elections was fueled while attending law school, not long after the Supreme Court's *Bush v. Gore* decision. After learning as much as she could about election administration and election law, Kristin put her interest into action, organizing law students to volunteer as non-partisan poll monitors in Cleveland, Ohio and later training lawyers to handle Election Day calls from voters with questions or experiencing difficulties voting.

Kristin saw first-hand the lengths some interests will go to suppress the vote, including fraudulent signs directing voters to a non-existent polling place and a fake "MySpace" page targeted at college students erroneously stating that members of one party voted on Tuesday and members of the other major party were supposed to vote the day after the election, on Wednesday.

Now, more than ever, misinformation about voting and elections is a threat to our democracy and has compelled Kristin to run for Contra Costa County Clerk-Recorder-Registrar. Kristin believes that transparency about the elections process and battling misinformation about how to vote will be critically important to maintaining confidence in the integrity of our elections – and our democracy.

Kristin is currently the President and CEO of the East Bay Leadership Council, an employer-led public policy advocacy organization focused on economic vitality and quality of life in the East Bay. She is also the Executive Director of the Contra Costa Economic Partnership.

In 2018, Kristin was elected to the Acalanes Union High School District Governing Board where she has worked through the complex challenges of educating students during the COVID-19 pandemic and has supported the expansion of both the District's equity work and the wellness resources on each campus.

A native of Martinez, Kristin earned a law degree from Fordham University, a master's in public policy from Georgetown University and a bachelor's from UCLA. After law school, she practiced employment law at the firm Sidley Austin LLP in New York City. Kristin is the co-chair of the statewide REAL Coalition of large business associations across California and serves on the Advisory Board of the Northern California Small Business Development Centers.

Kristin, and her husband T.J, live in Lafayette with their two teenage children.
